#### What is an EPC?

It provides two key things:

- A rating of the energy performance of your property in the form of an A-G graph similar to those used on domestic appliances.
- A set of recommendations indicating what actions can be undertaken to improve the energy performance of the property.

#### Why do I need one?

- It's a statutory requirement under the European Energy Performance of Building Directive.

- The recommendations report gives valuable information which will enhance understanding of your stock and help you assess the environmental impact on your local community and national programs.

- The EPC also gives information to your tenants about the environmental impact of your property and if recommendations are carried out this will provide your tenants with a real and visible reduction in their energy bills.
